Anailísí Traidisiúnta Traditional Analyses

- ▶ "Terrorism" is evil
- "The" state is fundamentally good
 - Or, at least, necessary and only occasionally problematic
- "The" state is a priori legitimate
 - Unworthy of critical scrutiny
- ▶ Non-state **violence** is **atavistic**

Tá Foréigean Comhchoiteann Violence is Communal

Foucault

- Power struggles permeate every social interaction
 - ► Conflict is a practice of the every day
- States are not completed, rather an assemblage of power relations
- Consequently, colonisation is not an event, but a practice

Schmitt

- States, institutions, deliberative democracy are all peripheral
- What matters is <u>The</u> Political
 - The distinction between Friend and Enemy, insider and outsider
- Inherent in the political, exclusive as it is, is always a trace of conflict and violence

- Writing
 - Policy
 - The **logocentric** *raison d'être* of International Relations and traditional Criminology
- Knowing
 - How is **colonisation done**?
- Doing
 - How is **resistance** done?
 - To neonazism, to neoliberalism: how do we *do* decolonisation?

Na Trioblóidí 1968 The Troubles 1968

- ▶ Gael ≈ Catholic ≈ Nationalist
- ▶ Briton ≈ Protestant ≈ Unionist
- ▶ 1960s: Gaels protest for civil rights, Britons riot, paramilitary violence
- ▶ 1968: Violence intensifies, ethnic enclaves, British Military "peacekeepers".
- 30-ish years of conflict for control of Northern Ireland
